NIC and Hansa agree to co-operate in this Pathway Agreement for the purpose of facilitating the admission of qualified students from Hansa to an academic program at NIC.

The following components comprise this agreement, and may be subject to review as mutually determined by the parties:

1.0 Admissions

- 1.1 All incoming applications are subject to evaluation in accordance with NIC admission procedures (see 1.4 below). Academic requirements are outlined in NIC' academic program pages and are updated annually.
- 1.2 English language proficiency requirements may be met through recognized Hansa's English for Academic Purposes program, as outlined in 2.0.
- 1.3 Applicants from Hansa will submit the following documents as part of their application to NIC (and this list may be updated as necessary):
 - A completed NIC application on Education Planner BC
 - Application fee
 - Official copies of high school and post-secondary transcripts from all institutions attended (both original and English translation).

6.4 Both institutions agree to act in accordance with the BC Personal Information Protection Act and share the applicant/student's personal and academic information to facilitate applicant/student admissions and enrollment.

7.0 Termination

7.1 This agreement shall cover a period of 36 months from date of signing. The Agreement shall automatically renew for a successive one year term unless one of the Parties terminates the Agreement as specified in section 6, or both parties agree to review and renew the Agreement on the basis of an ongoing evaluation of the academic success of Hansa clients at NIC.




- 7.2 Either party may terminate the agreement by sending written notification to the other party 10 working days prior to termination.
- 7.3 Either Party may terminate this Agreement in writing but without notice where the other Party:
- a. Has breached a material term of this Agreement and has not cured such breach within 30 days of receiving notice of such breach;
 - b. Becomes bankrupt, insolvent, or is dissolved; or
 - c. Has lost its accreditation from Languages Canada
- 7.4 Upon termination of this Agreement, all applications by Hansa students to NIC which were submitted prior to the Termination Date shall be assessed by NIC with regard to English language proficiency and equivalency according to the criteria established under this Agreement.

8.0 Force Majeure

- 8.1 Parties here to will be released from their obligations under this agreement in the event of national emergency, war, prohibitive government regulation or any other clause beyond the control of the parties hereto that renders the performance of this agreement impossible provided that any money that is due under this agreement shall become forthwith due and payable.
