



North Island College/Royal Roads University Guaranteed Admission Agreement Addendum

Guaranteed Admission

Eligible interested students admitted by North Island College (NIC) into the following NIC programs will be granted guaranteed admission to the related baccalaureate program at Royal Roads University (RRU). Through this guaranteed pathway, students will complete their first 60 credits of study (i.e., years one and two) at NIC and their last 60-67.5 credits of study (i.e., years three and four) at RRU. Requirements for progression to an undergraduate degree completion program at RRU include the following:

- successful completion of an NIC pathway diploma and,
- achieving a minimum “B” or 3.00/4.33 GPA and,
- satisfactorily completing the appropriate prerequisites and,
- meeting any required work experience criteria.

With the agreement of both institutions and amendment to this document, additional programs may be added to the list available for guaranteed admission. Should an institution plan to change, suspend, or discontinue a program, sufficient notice will be provided to the partner institution so that the educational plans of students and of the partner institution are duly considered.

Application

A limited number of seats will be held at RRU for NIC students who are considering this guaranteed pathway. To take advantage of this agreement, students will first apply to an NIC pathway program. Students will indicate to an NIC Educational Advisor their intention to pursue this guaranteed pathway to RRU, preferably at least 6 months, but no later than 3 months, prior to the eligible RRU program start date. In addition, students will be required to apply directly to RRU in advance of posted deadlines; an application fee waiver code will be provided by NIC. NIC will provide student declaration and transcript information directly to RRU. Students will not be required to submit transcripts from high school or other higher education institutions previously attended.

Student Admissibility and Admission Procedures

To be admissible to a 'guaranteed admission' pathway, students must:

- meet the entry and prerequisite requirements of NIC,
- sign a waiver granting RRU access to their NIC student record including any issue, that might affect progression to RRU.

Student Fees

Students will pay the required tuition and ancillary fees to the institution in which they are currently enrolled by the applicable deadlines and according to that institution's policies. Each institution will keep the student informed of fee deadlines at their respective institutions.

Student Services

Students may access the advising and other support services at the institution in which they are currently enrolled. Students interested in the pathway option outlined in this agreement will be directed to an educational advisor at NIC; and an enrolment advisor at RRU.
